- \$150 security deposit payable at the start of the rental agreement, refundable upon safe return of the instrument to Presto Instruments.

INSTRUMENT HIRE & RENTAL TERMS AND CONDITIONS

I hereby agree to lease a musical instrument as specified on the lease agreement and made available by Presto Instruments Pty Ltd, on the terms and conditions listed below.

- 1. I agree to have my nominated credit card charged for all scheduled fees.
- **2.** I agree to my nominated credit card being charged a \$150 security deposit that is refundable to my credit card upon safe return of the instrument to Presto Instruments.
- 3. I agree to maintain and keep my instrument in good working order.
- 4. I agree that the instrument remains the property of Presto Instruments Pty Ltd.
- **5.** I agree to the initial 4-month minimum rental period and I then agree to rent my instrument on a month to month basis.
- **6.** If I wish to cancel my rental, I will email Presto Instruments at sales@prestoinstruments.com.au providing at least 30 days notice of cancellation. Failure to provide adequate notice of cancellation will result in a full month's rental charge.
- 7. I agree to provide my current credit card details to Presto Instruments and consent to my card being debited at the beginning of the rental period and then each subsequent month for the duration of the agreed rental period.
- **8.** I agree to take out insurance for the musical instrument against fire, loss, theft and /or damage with a reputable and legally licensed insurer.
- 9. I agree not to sell or offer for sale, assign, pledge, lend or otherwise deal with the musical instrument.
- **10.** I agree that I am responsible for any loss or damage incurred to the musical instrument whilst in my possession.

- 11. I agree that Presto Instruments will be notified of any damage or loss to the musical instrument within a period of no more than 48 hours.
- 12. I agree that I will pay Presto Instruments for the cost of any repairs deemed necessary as a result of loss or damage incurred. Should the musical instrument be deemed not repairable or cannot be located, I will provide payment for the total value of the music instrument. I understand that the value of the instrument will be assessed by Presto Instruments and that the assessment is the amount payable in accordance with these terms and conditions.
- 13. Hirers agree to not attempt to repair the instrument themselves.
- **14.** Presto Instruments reserves the right to alter the terms and conditions of this agreement and fees associated to this agreement with no less than 60 days notice to the hirer.
- **15.** General servicing for wear and tear is the responsibility of the hirer. When you hire an instrument from us it has been checked, serviced and is in good working order. If there is anything wrong with the instrument when you receive it, please contact us immediately. We recommend instruments be serviced by a qualified technician at least once a year and we require the instrument to be returned to us in good working order.

PRIVACY ACT

I acknowledge that under the Privacy Act 1988 the lessor is allowed to and may give to a credit reporting agency personal information contained in this application or otherwise acquired by the lessor concerning the conduct of my credit account. If and to the extent that the lessor does so in a manner and for purposes that conform with the Privacy Act I agree to the lessor obtaining information about my commercial activities and commercial credit worthiness from a business which provides information about the commercial credit worthiness of persons and to the lessor using that information in assessing my application for credit.
