

Band Programs Agreement

INSTRUMENTS

- All band members are required to have an instrument in time for their first rehearsal where possible.
- The Music Partnership does not provide instruments to students. Each student is responsible for the hire or purchase of his or her instrument.

MISSED REHEARSALS

 Missed band rehearsals are unfortunately not refundable. Band is a big commitment, and we require all students enrolledas band members to be there each week.

COMMITMENT

- All band members are expected to commit to the program for a minimum of one (1) school term. This allows students to give the band a good go. Sometimes it takes a few terms to really start getting the hang of things.
- Any band member wishing to discontinue their band program enrolment should email The Music Partnership 2 weeks prior to the commencement of the next school term. Please email info@musicpartnership.com.au

EXPECTATIONS

- All band members are required to bring their instrument and all relevant music to each band rehearsal.
- All band members are expected to attend all rehearsals and performances as advised.
- All band members are required to practice their instrument at home on a regular basis.
- All band members are expected to behave appropriately during all band rehearsals.

FEES & PAYMENT

Please refer to your school's page (select your school from the drop down menu found on our 'Band Programs' page) to view
the breakdown of band fees. This agreed program fee is payable to "The Music Partnership Pty Limited".
 There will also be a performance contribution fee of \$10+GST per child per term. This is to help cover the conductor fees
when the bands perform.



Band Programs Agreement (continued)

- All band tuition fees include band rehearsals, performances and music as specified. Drum kit, keyboards, amplifiers, and music stands are all provided for use at each rehearsal.
- An invoice will be sent in Week 1 of each school term to the student's family via email. The invoice is payable by the end of Week 3. Rehearsal numbers per term vary according to the NSW school terms.
- Failure to pay within the allocated time frame will result in a late fee of \$5.00 for the first week overdue and \$10.00 for every subsequent week overdue until the full amount is paid.
- Refunds / credits are not offered except under exceptional circumstances.
- In accepting your band spot, you also agree to pay your invoice each term within the agreed time frames. Failure to pay foryour band enrolment on time may result in your account being forwarded to a debt collection agency and your band spot suspended. If you are having trouble paying your account, please contact The Music Partnership Pty Limited to discuss a payment plan. We are happy to help if we can.

METHODS OF PAYMENT

- Payment must be made directly to The Music Partnership Pty Limited via the following methods:
 - Online Bank Transfer (our preferred method) bank details are on your invoice
 - Credit card payment over the phone or by filling out our credit card authorisation form to set up direct debit

PLEASE NOTE

- The Music Partnership conductors are responsible for their students during official allocated rehearsal times only. We do not take responsibility for children outside of these times.
- In accepting your band enrolment with us you are agreeing and accepting our agreement for band programs. Please be sure to keep this document on file for your reference.
